**ADMINISTRATIVE ORDER ASSIGNING
JUDGES TO WEEKEND FIRST APPEARANCE FOR 2009**

(a) Florida Rule of Judicial Administration 2.215(b)(3) states the chief judge shall “develop an administrative plan for the efficient and proper administration of all courts within that circuit.”

(b) In accordance with the authority vested in the chief judge by Florida Rule of Judicial Administration 2.215, it is ordered:

(1) This Administrative Order shall govern the assignment of judges to preside over first appearances on Saturday and Sunday at 8:30 a.m. at the Central Courthouse located at 201 S.E. Sixth Street, Fort Lauderdale, Florida 33301.

(2) In the event a judge is not able to preside as first appearance judge for his or her weekend, the judge is responsible for securing a replacement judge and advising the Chief Judge, Trial Court Administrator, and Clerk of Court, in writing, of his or her replacement.

(3) If a judge should resign, retire, or be re-assigned, the judge assuming the division will be responsible for the weekend first appearance for the originally assigned judge.

(4) The schedule for 2009 first appearance coverage is attached hereto.
