**ADMINISTRATIVE ORDER ASSIGNING JUDGES TO
DEPARTMENT OF TRANSPORTATION ORDERS OF TAKING AND
DETERMINATIONS OF PROBABLE CAUSE FOR
CIVIL FORFEITURE PROCEEDINGS FOR 2008**

(a) Florida Rule of Judicial Administration 2.215(b)(3) states the chief judge shall "develop an administrative plan for the efficient and proper administration of all courts within that circuit."

(b) In accordance with the authority vested in the chief judge by Florida Rule of Judicial Administration 2.215, it is ordered:

(1) This Administrative Order shall govern the assignment of judges to preside over Department of Transportation orders of taking in eminent domain and determination of probable cause for Chapter 732, Fla. Stat., civil forfeiture proceedings.

(2) The assigned judge shall be available for a one (1) week period commencing Tuesday at 8:30 a.m., as needed, to hear or review these matters.

(3) If a judge should resign, retire, or be re-assigned, the judge assuming the division will be responsible for the week for that division.

(4) In the event a judge is not able to preside for his or her assigned week, the judge is responsible for securing a replacement judge and advising the Chief Judge and Trial Court Administrator, in writing, of his or her replacement.

(5) The schedule for 2008 coverage is attached hereto.

(6) This Administrative Order replaces and supersedes Administrative Order II-07-B-2.
