**ADMINISTRATIVE ORDER ASSIGNING  
JUDGES TO CIRCUIT DUTY COVERAGE FOR 2008**

---

(a) Florida Rule of Judicial Administration 2.215(b)(3) states the chief judge shall “develop an administrative plan for the efficient and proper administration of all courts within that circuit.”

(b) In accordance with the authority vested in the chief judge by Florida Rule of Judicial Administration 2.215, it is ordered:

(1) This Administrative Order shall govern the assignment of judges to preside over emergency matters presented during court business hours when the assigned judge is unavailable and for emergency matters presented after court business hours.

(2) There shall be a duty judge for circuit civil matters (including probate and unified family court) and circuit criminal matters.

(3) The criminal duty judge shall be responsible for search warrants, arrest warrants, and pen registers. The criminal duty judge shall give priority to the signing of warrants and shall expedite the signing of warrants over any and all other duties and responsibilities as a judge. The criminal duty judge shall sign Probation and Violation of Community Control Warrants in the absence of the assigned judge and alternate judge when there is an allegation of imminent danger to public safety.

(4) The civil and criminal duty judges shall be available for a one (1) week period commencing Friday at 8:30 a.m. and ending the next Friday at 8:30 a.m.

(5) The civil and criminal duty judges shall be in close proximity to the central courthouse during business hours and shall be available by telephone after business hours.

(6) The civil and criminal duty judge shall provide a telephone number at which he or she may be reached twenty four (24) hours per day to the Chief Judge, Trial Court Administrator, and Duty Officer of the Broward County Sheriff’s Office. The telephone number shall be exempt from public access pursuant to Florida Rule of Judicial Administration 2.420.

(7) If a judge should resign, retire, or be re-assigned, the judge assuming the division will be responsible for the duty week for that division.

(8) In the event a judge is not able to preside as duty judge for his or her assigned week, the judge is responsible for securing a replacement judge and advising the Chief Judge and Trial Court Administrator, in writing, of his or her replacement.

(9) The schedule for 2008 duty coverage is attached hereto.

(10) This Administrative Order replaces and supersedes Administrative Order I-07-C-4.
