MOTION CALENDAR (NON-EVIDENTIARY HEARINGS):

Fridays at 8:45 a.m.

For all Motions scheduled (including re-notices) please submit a copy of the notice of hearing, the motion including all supporting documents, a copy of your online scheduling confirmation, and a signed Order of Referral to Magistrate Miranda’s office 5 business days prior to the hearing date.

You must have a signed Order of Referral to General Magistrate before scheduling the hearing.

CHILD SUPPORT CALENDAR:

Motions for temporary child support and motions for contempt/enforcement for nonpayment of child support (that can be completed within 15 minutes) may be scheduled on the child support calendar.

Child Support Calendar is held on the 2nd and 4th Wednesday mornings every month. Please consult the online Child Support Calendar System for specific dates and times.

You must have a signed Order of Referral to Hearing Officer by the date of your hearing, but you may schedule the hearing prior to the entry of the Referral. Please bring a copy of the Referral with you to the hearing.

SPECIAL SET HEARINGS AND TRIALS:

Please call the Magistrate's assistant (Tirese Warren) to set a special set hearing and/or trial. Before you call for a hearing/trial date, obtain an Order of Referral from the assigned Judge. When calling the Magistrate's office please conference in opposing counsel's assistant so that the date and time can be coordinated.

Please submit a copy of the Notice of Hearing, Motion and Order of Referral to Magistrate Miranda's office within 7 days after scheduling the hearing.
