### AMENDED ADMINISTRATIVE ORDER ESTABLISHING CASE STATUS REPORTING REQUIREMENTS FOR REAL PROPERTY MORTGAGE FORECLOSURE CASES

(to correct a scrivener's error in the first order)

(a) Florida Rule of Judicial Administration 2.215(b)(3) states the chief judge shall "considering available resources, ensure the efficient and proper administration of all courts within [this] circuit."

(b) The Florida Supreme Court adopted requirements for FY 2013-2014 Foreclosure Initiative Data Collection Plan in AOSC 13-51 which directed the adoption of a circuit administrative order.

(c) In accordance with the authority vested in the chief judge by Florida Rule of Judicial Administration 2.215, it is ordered:

(1) The Clerk of Courts (Clerk) is directed to comply with the requirements of the FY 2013-2014 Foreclosure Initiative Data Collection Plan adopted by the Florida Supreme Court in AOSC 13-51.

(2) If the Clerk is aware of any event which may change the status of a real property mortgage foreclosure case, he shall immediately notify the judge assigned to Division 11.

(3) The Court shall enter orders as necessary upon the change of status of a real property mortgage foreclosure case. The form of the orders is attached to this Administrative Order.
