UNIFORM MOTION CALENDAR: NON-EVIDENTIARY HEARINGS

**For all Motions scheduled, including re-notices, please submit
a copy of the notice of hearing, the motion (including all
supporting documents), a copy of your online scheduling
confirmation, and Order of Referral to General Magistrate
Beilly's chambers 5 business days prior to the hearing date.**

**All Motions scheduled online must be cancelled online if the
hearing is no longer needed.**

CHILD SUPPORT CALENDAR:

Motions for temporary child support and motions for contempt/enforcement for nonpayment of child support that can be completed within 15 minutes may be scheduled on the child support calendar.

Child Support Calendar is held 2 times per month on Wednesday mornings. Please consult the online Child Support Calendar System for specific dates and times. A minimum of 2 weeks notice is required.

You must have an Order of Referral to Hearing Officer by the day of your hearing.

For all Motions scheduled, including re-notices, please submit a copy of the notice of hearing, the motion (including all supporting documents), and a copy of your online scheduling confirmation to General Magistrate Beilly's chambers 7 business days prior to the hearing date.

All child support motions scheduled online that have been resolved or are cancelled must be cancelled online. Then, you must submit an Agreed Recommended Order of Hearing Officer and Order ratifying same with 2 sets of envelopes to the Hearing Officer.

SPECIAL SET HEARINGS: (1 ½ hours or less)

Please call the Magistrate's assistant to set a special set hearing. Before you call in for a hearing date you must obtain an Order of Referral from the assigned Judge. When calling the Magistrate's office please conference in opposing counsel's assistant so that the date and time can be coordinated.

Please submit a copy of the Notice of Hearing, Motion and Order of Referral to Magistrate Beilly's chambers within 7 days from the date of scheduling the hearing.

TRIAL DOCKET: The Magistrate has a monthly trial calendar.

Please call the Magistrate's assistant to set a hearing on the trial docket. The Court requires a telephone conference case management conference before scheduling a hearing on the trial docket.
