**ADMINISTRATIVE ORDER DIRECTING THE CLERK OF THE COURT
TO TRANSFER CASES FROM DIVISION 38 TO DIVISION 42**

- (a) Pursuant to Article V, section 2(d) of the Florida Constitution, and section 43.26, Florida Statutes, the chief judge of each judicial circuit is charged with the authority and the power to do everything necessary to promote the prompt and efficient administration of justice.
- (b) Florida Rule of Judicial Administration 2.215(b)(3) states the chief judge “shall, considering available resources, ensure the efficient and proper administration of all courts within [this] circuit.”
- (c) Florida Rule of Judicial Administration 2.215(b)(4) permits the chief judge to assign cases to judges.
- (d) In accordance with the authority vested in the chief judge by Article V, section 2(d) of the Florida Constitution, section 43.26, Florida Statutes, and Florida Rule of Judicial Administration, it is hereby **ORDERED**:
- (e) The Clerk of the Court shall transfer the cases listed on Attachment “A” from Division 38 to Division 42.
