#### "A Silver Linings Playbook" By: Judge Tarlika Navarro, Drug Court Judge Seventeenth Judicial Circuit

The COVID-19 pandemic is proving to be one of the most challenging and unprecedented events in our country's history. It has changed our lives in more ways than any of us could ever have imagined and while our Judiciary and our drug court team work tirelessly to maintain essential operations , our team is dedicated to pivoting through the challenges and finding the silver lining in all we encounter as a drug court community.

And yet, there were a lot of positives that have and will change the trajectory of our Drug Court Program. Our drug court team has witnessed the silver lining in transitioning from in-person court appearances to Zoom-court appearances. The drastic benefits have become irrefutable. Drug court participants are able to zoom into court hearings while working. They do not have to take three or more buses for transit, they do not have to pay a daily rate for parking, find babysitters, arrange child care, and so on.

Similarly, the Court is able to "zoom into the lives" of our participants; such as, meeting family members, bosses, significant others, their children and others who support and contribute to the recovery of our drug court participants. Our drug court team is able to more closely monitor our participants if needed, and virtual Court provides our participants with access to our courtroom to address any issues that may arise with their recovery, treatment, housing etc.

We see daily the benefits of virtual Court through drug court participation and successful completions. Since our last formal Drug Court graduation in February 2020, 366 drug court participants have successfully graduated, resulting in soon-to-be fire fighters, emergency care workers, pre-law students and a myriad of other professions. They will soon contribute back to our community tenfold. And isn't that essentially what a problem-solving Court should aim to accomplish?

#### "Thinking Outside the Drop Box" By Eve Janocko, Chief Deputy Court Administrator Fourth Judicial Circuit

The Fourth Judicial Circuit runs an in-house, drug court lab processing specimens for all ten problem-solving courts as well as child welfare agencies. When the pandemic hit, all specimen collection and lab operations were halted at the Duval County Courthouse. To address the critical need for accountability, Teri Hamlyn, Director of the Fourth Judicial Circuit's Problem-Solving Courts worked with a local vendor to quickly transition clients onto drug patches. Using drug patches was a good alternative but proved problematic with clients questioning the results from these devices. Ms. Hamlyn coordinated training for the PSC teams so they understood the efficacy of the drug patches and could converse with clients. Fast forward seven months, frustration mounted. Participants created improbable explanations for the positive tests, which were at times comical.

One of our main treatment providers offered an off-site location so that specimen collection could begin once again. Ms. Hamlyn ordered PPE and trained PSC staff on pandemic safety protocols for specimen collection at the alternate location. Crisis begets creativity. The Fourth Circuit is indeed fortunate to have a multi-talented Director who oversees ten PSCs and consistently goes above and beyond to find a solution no matter what box she must open.

#### "Snatching Victory from the Agony of the Pandemic" By Stacy Roberts, Drug Court Program Coordinator First Judicial Circuit

Despite financial stress and isolation, the participants in Escambia and Okaloosa counties have proved that their desire for recovery and the drug court team's continued assistance keeps their recovery an attainable goal despite the pandemic. Our Drug Court Programs quickly transitioned to virtual court hearings and individual/group treatment sessions within a couple of weeks after court closures. Drug court team members increased their telephone contact with each participant to ensure they knew that they were not alone by providing support and assistance. It was amazing to witness how effective the utilization of virtual court and treatment could be for our participants. In fact, the drug court virtual experience has been surprisingly efficient as participants no longer have to travel to/from court and treatment sessions saving them time spent away from their support systems and employment.

#### **CERTIFICATION UPDATE**

As most of you know, the Certification Subcommittee of the Supreme Court Steering Committee on Problem-Solving Courts has been working over the last three years to create a certification system. That work continues!

We are currently awaiting the approval of the proposed certification plan considered by the Florida Supreme Court on April 20, 2021. Once the plan is approved, we can set a schedule for certification applications. In the meantime, we are working on producing a webinar to bring you more information about the proposed plan. ### **THE BUDGET: The Good, The Bad, and the Not So Ugly** By Jennifer Grandal, Senior Court Operations Consultant, Office of the State Courts Administrator



With the conclusion of the 2021 legislative session on April 30th and the passage of the Fiscal Year 2021-22 state budget, we can breathe a sigh of relief knowing that State Courts System's budget faired very well this year. While the Governor must still provide final authorization of the state budget, the court's problem-solving court appropriation, which provides funding through the trial courts for drug courts and other problem-solving courts, was maintained at the same level as last year with no reductions. In addition, the Legislature included language in the General Appropriations Act that allows for unspent funds from this fiscal year to revert and be reappropriated next year for spending. This is especially helpful this year because funds that were either held back or spent conservatively by the circuits due to the budget reduction exercise implemented earlier this year will be available for spending next year. The Problem-Solving Court Advisory Group and the Trial Court Budget Commission are currently in the process of making decisions on next year's allocations and the process for making the additional funding available for next year. More information will be shared with the circuits as final decisions are made!

#### SUPREME COURT COMMITTEE ON PROBLEM-SOLVING COURTS

*"The Latest Happenings" By The Honorable Steve Leifman, Chair* 



The Florida Supreme Court became more involved in behavioral health issues in 2007 when they created a Mental Health Subcommittee within the Steering Committee on Families and Children in the Court. The subcommittee subsequently became the Task Force on Substance Abuse and Mental Health and in 2018 it evolved into the Steering Committee on Problem Solving Courts.

The Steering Committee is tasked with developing best practice standards and guidelines for problem-solving courts and implementing the recommendations previously made by the Task Force. These recommendations include establishing a re-entry program for prison inmates with substance use and mental health disorders as well as making improvements to the Baker and Marchman Acts.

To date, the Supreme Court has approved the Adult Drug Court Best Practice Standards and Early Childhood Court Best Practice Standards (developed by FCC Steering Committee). The Steering Committee has recently developed Dependency Drug Court Best Practice Standards, Mental Health Court Best Practice Guidelines, and Veterans Court Best Practice Guidelines that are expected to be ready for court consideration this year. More recently, the Steering Committee has started their research on the development of standards or guidelines for juvenile drug courts and DUI courts.

Equally important has been the development of a Certification Program for our problem solving courts that has been presented to the Supreme Court and is pending final approval. Eventually, funding for the problem solving courts will be tied to meeting the approved standards.

We are currently providing guidance on statewide training initiatives on best practices and we are working with OSCA on a series of training programs on Stimulants. The Steering Committee is also developing recommendations for judicial branch emergency preparedness on the needs and expectations of problem-solving court participants and the courts during times of pandemic, natural disasters, and other unexpected events that may lead to court closures or alternative means of holding court.
