*Administrative Order 2021-30-CO*

**ESTABLISHING COURTHOUSE  
LOCATIONS AND CASE DISTRIBUTION FOR COUNTY AND  
MUNICIPAL ORDINANCE VIOLATIONS, AND MISDEMEANORS**

---

(a) Pursuant to Article V, section 2(d) of the Florida Constitution and section 43.26, Florida Statutes, the chief judge of each judicial circuit is charged with the authority and power to do everything necessary to promote the prompt and efficient administration of justice.

(b) Florida Rule of Judicial Administration 2.215(b)(3) states the chief judge “shall, considering available resources, ensure the efficient and proper administration of all courts within [this] circuit.”

(c) The Broward County Board of County Commissioners has established four (4) courthouses in Broward County. The Broward County Central Judicial Complex is located at 201 S.E. Sixth Street, Fort Lauderdale, Florida 33301 (“Central Courthouse”). The North Regional Courthouse is located at 1600 West Hillsboro Boulevard, Deerfield Beach, Florida 33442 (“North Regional Courthouse”). The South Regional Courthouse is located at 3550 Hollywood Boulevard, Hollywood, Florida 33021 (“South Regional Courthouse”). The West Regional Courthouse is located at 100 North Pine Island Road, Plantation, Florida 33324 (“West Regional Courthouse”). For purposes of this Administrative Order, the Central Courthouse, North Regional Courthouse, South Regional Courthouse, and West Regional Courthouse will collectively be referred to as the “Broward County Courthouses.”

(d) In accordance with the authority vested in the Chief Judge by Article V, section 2(d) of the Florida Constitution, section 43.26, Florida Statute, and Florida Rule of Judicial Administration 2.215, it is hereby **ORDERED, effective July 15, 2021:**

(1) County ordinance violations, misdemeanors, and municipal ordinance violations shall be filed and heard as indicated below, except as otherwise provided herein:

(2) Cases filed in accordance with this administrative order that are required to be filed to a satellite courthouse location (North, South, or West) shall be assigned by the Clerk of Court to the judicial officers assigned to the county criminal divisions at these courthouse locations in as equal a distribution as possible, except as set forth herein or as otherwise directed by memorandum from the Chief Judge or Administrative Judge of the County Court.

(3) Cases filed prior to the effective date of this Administrative Order shall remain with the originally assigned courthouse location and county criminal judicial division assigned at the time of filing.

(4) Cases involving a charge of DUI and which are designated by the prefix “MU” shall be filed to the Central Courthouse location and assigned to county criminal judicial officers at the Central Courthouse location in as equal a distribution as possible.

(5) Misdemeanor (MM) and traffic criminal (TC) cases filed by the City of Fort Lauderdale shall be filed to the Central Courthouse location and assigned to the county criminal judicial officers at the Central Courthouse location in as equal a distribution as possible.

(6) Any State of Florida agency, department, division, or office not reflected in paragraph (1) shall file its initiating criminal documents at the Central Courthouse and such matters shall be assigned to County Civil Division MS.

(7) This Administrative Order vacates and supersedes Administrative Order 2019-72-CO on July 15, 2021.
