**TEMPORARILY APPOINTING CIRCUIT COURT JUDGES TO COUNTY
COURT AND COUNTY COURT JUDGES TO CIRCUIT COURT FOR
THE THIRD QUARTER OF FISCAL YEAR 2025-2026**

(a) Pursuant to Article V, section 2(d) of the Florida Constitution and section 43.26, Florida Statutes, the chief judge of each judicial circuit is charged with the authority and power to do everything necessary to promote the prompt and efficient administration of justice.

(b) Florida Rule of General Practice and Judicial Administration 2.215(b)(3) states the Chief Judge “ensures the efficient and proper administration of all courts within [this] circuit, considering available resources.”

(c) Florida Rule of General Practice and Judicial Administration 2.215(b)(4) authorizes the Chief Judge to assign judges to courts and divisions.

(d) In accordance with the authority vested in the Chief Judge pursuant to Article V, section 2(d) of the Florida Constitution, section 43.26, Florida Statutes, and Florida Rule of General Practice and Judicial Administration 2.215, it is hereby **ORDERED, effective January 1, 2026:**
