**AMENDED<sup>1</sup> ADMINISTRATIVE ORDER REGARDING THE TRANSFER  
OF POST-ENGLE TOBACCO CASES**

(a) Florida Rule of Judicial Administration 2.215 (b) (3) states the Chief Judge “shall, considering available resources, ensure the efficient and proper administration of all courts within [this] circuit.”

(b) Pursuant to Administrative Order 2007-48-Civ, all pending, re-opened and new filings in the Product Liability Tobacco cases assigned to Circuit Civil Division (19).
