### Welcome to LIHEAP

#### What is the LIHEAP Program?

The LIHEAP (Low Income Home Energy Assistance Program) is a federally funded program that provides support to needy lowincome households for utility bill payments. Support is provided on a first come-first served basis, so apply early.

#### How do I qualify?

- Must be a Broward County resident
- Household income at or below 150% of the Poverty Guidelines

#### How do I apply?

Call 954-357-5025 for dates and times to complete and drop off your application.

Submit an application and supporting documents at one of our satellite offices (reverse side of brochure).

# What supporting documents should I bring when I apply?

- An FPL bill in the name of an adult member of the household
- State of Florida picture identification showing Broward County address (for all persons over 18)
- Proof of immigration status (permanent residence) for all non-US citizens
- Social Security Cards for all household members
- Birth Certificates for children age 5 or younger
- Proof of income (see column to the right)
- Current Section 8 or Public Housing Contract, and Form 50059 showing current utility allowance
- Clients must provide their own copies

Additional documents may be requested upon review of your application.



### **Proof of Income**

What proof of income documents must I provide?

Provide the following documentation for ALL household members:

- Pay stubs for last 30 days
- Company letterhead verifying start date, pay rate, frequency of pay, and average hours worked per week
- Unemployment Wage Determination
  Statement
- Unemployment check stubs for last 30 days
- Current Social Security, Disability and/or SSI Benefit Statement
- Current Pension Statement
- Current Veterans' Benefits
- Current Workers' Compensation Benefits
- Current Retirement Benefit Statement
- Child Support Verification
- Clients must provide their own copies
